Dear Members,

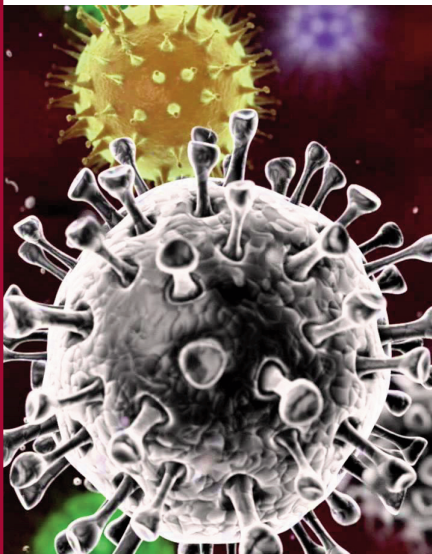

## **CORONAVIRUS BASIC PROTECTIVE MEASURES**
